SEVERE UNIT RESIDENTIAL PROGRAM SERVES STUDENTS, AGES 6 TO 22, FROM ACROSS THE UNITED STATES; THIS PROGRAM OPERATES 365 DAYS PER YEAR. NECC'S SEVERE UNIT PROGRAM IS DESIGNED FOR STUDENTS WHO DEMONSTRATE SIGNIFICANT SELF-INJURY AND OTHER SEVERE CHALLENGING BEHAVIORS. STUDENTS LIVE IN INTENSIVELY STAFFED COMMUNITY BASED GROUP HOMES OR A SPECIALLY DESIGNED FOUR-APARTMENT HOME IN A RESIDENTIAL NEIGHBORHOOD CLOSE TO THE SOUTHBOROUGH CAMPUS. INSTRUCTION IS PRIMARILY GIVEN IN A ONE-TO-ONE STAFF-TO-STUDENT RATIO, WITH TEACHERS WORKING BOTH IN THE SCHOOL AND THE RESIDENCE. THE ULTIMATE GOAL OF THIS INTENSIVE INSTRUCTION IS TO DECREASE THE STUDENT'S DANGEROUS AND SEVERE BEHAVIORS AND INCREASE HIS/HER CAPACITY TO FUNCTION AND COMMUNICATE INDEPENDENTLY. IN THIS WAY THE STUDENT CAN BE PREPARED TO MOVE ON TO

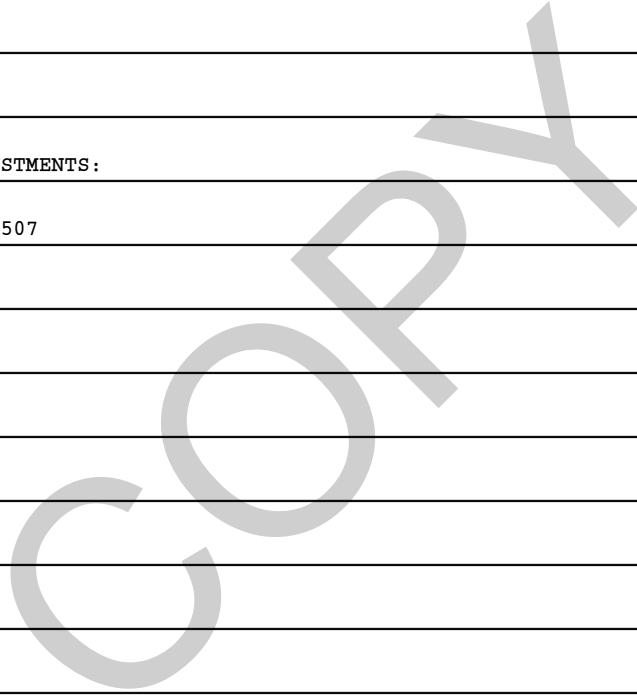

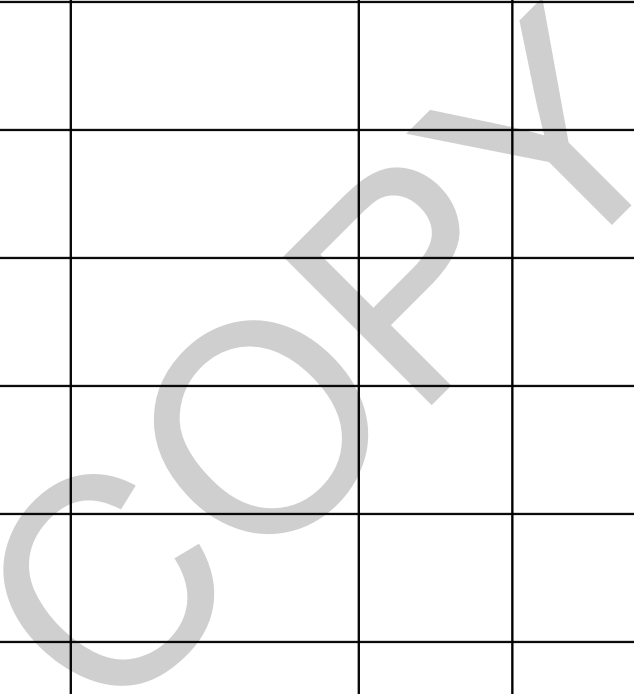

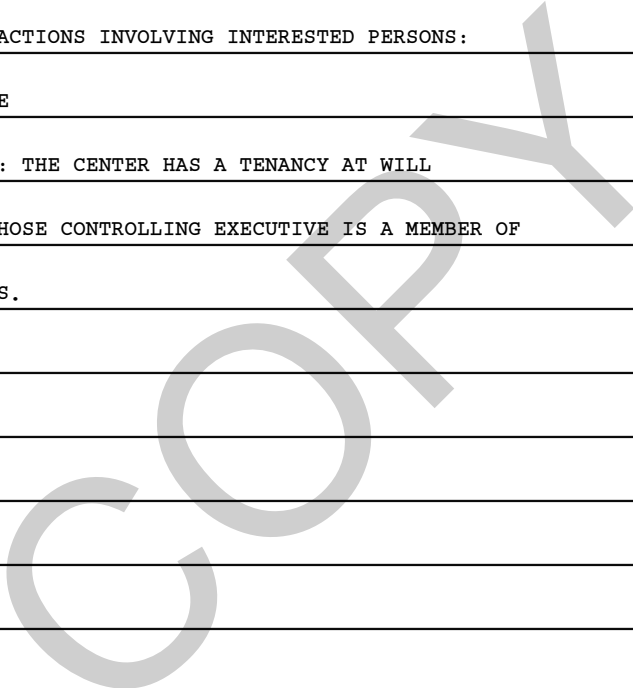
